The World Anti Doping Agency (WADA) has published the 2017 Prohibited List to be effective from 1<sup>st</sup> January 2017 worldwide. The List, which is one of the International Standards mandatory for the Stakeholders of the Country designates what substances and methods are prohibited both In- and Out of Competition and which substances are banned in particular sports.

NADA would like to make you aware that the Prohibited List 2017 and its modifications are easily accessible for athletes and their entourage on our website [www.nada.nic.in](http://www.nada.nic.in) and that you are proactively communicating them to athletes and entourage via direct communication channels that you may have at your disposal.

While ultimately the athletes are responsible for what substances and methods are on the prohibited list and for the substances in his or her body, let's make sure that we can make them aware in this regard to help keep them clean.

A copy of the Prohibited List 2017 to be effective from 1<sup>st</sup> January 2017 alongwith the Summary of Changes is enclosed herewith for wide circulation.
